RCS provides training and support to ensure that faculty, students, and staff remain in compliance while conducting the innovative research that makes UConn a world-class research institution.

To achieve this, RCS works with faculty oversight committees to promote the ethical and responsible conduct of research and to ensure compliance with regulatory requirements relating to research involving human participants, vertebrate animal subjects, recombinant/synthetic DNA, biohazards, and stem cells. The committees supported by this office include the Institutional Animal Care and Use Committee (IACUC), the Institutional Review Board (IRB), the Financial Conflict of Interest in Research Committee (FCOIRC), the Institutional Biosafety Committee (IBC) and the Stem Cell Research Oversight Committee (SCRO). Research Compliance Services also has responsibilities relating to Export Control, ClinicalTrials.gov, and Responsible Conduct of Research.
